SEXUAL HEALTH IN PRIMARY CARE SERVICE SPECIFICATION

1 INTRODUCTION

This Service Specification along with the Contract Detail forms the Local Enhanced Service (LES) for a Sexual Health service delivered in primary care.

This Service Specification works towards meeting the Scottish Government priorities and NHSH Local Delivery Plan (LDP): Outcome 3, Stay well and Outcome 4, Anchor well.

2 CLINICAL SPECIFICATION

This contract is a two-tier LES for comprehensive sexual health assessment, screening and management; within a timely manner in keeping with national guidance.

- Tier 1 comprehensive sexual health assessment, screening & management of asymptomatic STIs within the primary care setting.
- Tier 2 comprehensive sexual health assessment, examination and management of symptomatic STIs / genital tract infections within the primary care setting.

Purpose

The purpose of the contract is to provide equitable access to sexual health care and STI screening of patients in NHS Highland.

Service Aims

To provide a comprehensive sexual health assessment & screening service, with appropriate treatment locally, or onward referral if appropriate, to the patient population within a primary care setting.

Service Criteria

Enhanced service requirement

From 1 October 2024, the Practice should:

Confirm if the practice wishes to participate in Tier 1 only or both.

Ensure the correct clinical coding and template is used to ensure compliance with the recording and monitoring requirements of the LES.

Tier 1

Undertake comprehensive sexual history and risk assessment

- Assess the risk of pregnancy and identify the need for emergency contraception.
- Be aware of religious, cultural and social factors and how these may influence presentation and management.
- Identify safeguarding issues in under 18s and vulnerable adults, with referral as appropriate.
- Identify the need for HIV post-exposure prophylaxis following sexual exposure (PEPSE).
- Identify sexual assault, including female genital mutilation, with referral as appropriate

Opportunistically promote "safer sex" with all patients

- Give clear information to patients regarding safer sex practices, including condom use and where the patient can access these. Participating practices should hold stock and distribute condoms/sheaths, if requested and/or appropriate.
- Advise on appropriate changes to sexual behaviour to reduce risk.

Provide a full screen for asymptomatic STIs

- Take an appropriate and adequate sample of urine (or a self-taken low vaginal swab) to test for chlamydia and gonorrhoea and a sample of blood to test for syphilis and HIV,

- where appropriate.
- Screening for hepatitis B and hepatitis C where appropriate.
- Consideration of (and if appropriate referral for) hepatitis B vaccination for at risk groups.
- Ensure that patients are aware of the infections that they are being screened for and arrange how the client will be informed of their results e.g., phone, text, or letter.
- Ensure that the client is aware that positive results for certain infections (e.g. gonorrhoea, syphilis, HIV) will require referral to the Highland Sexual Health service for treatment and partner notification.

Manage positive results

- Inform the client of their results using the agreed means of communication.
- For a positive **chlamydia** result: Treatment should be in accordance with TAMs.
- Patients may, with their agreement, be referred to the Highland Sexual Health service for partner notification.
- For a positive **Gonorrhoea**, **Syphilis or HIV** result patients should be referred to the Highland Sexual Health service for treatment and partner notification.

Screening for HIV

- Offer an HIV test as part of a full sexual health screen.
- Discuss HIV testing, including issues specific to pregnant women.

Screening of men who have sex with men (MSM)

It is recommended that MSM (including those who are asymptomatic) are referred to the Highland Sexual Health service for assessment and treatment.

Tier 2 – as above plus the following

To assess and manage suspected genital tract infections, requiring intimate physical examination (where a comprehensive sexual health assessment, including examination, has been undertaken).

- Take appropriate and adequate specimens.
- Correctly interpret test results.
- Clearly explain the diagnosis and management to the patient, referring to or liaising with other colleagues as appropriate.

To undertake genital examination where appropriate

- Explain procedure to patient.
- Elicit physical signs with minimal discomfort to patient.
- Be aware of patient dignity and ensure chaperone is offered.
- Demonstrate skilful use of instruments.

To refer for partner notification and contact tracing in line with national guidelines

- Explain the reasons for partner notification and contact tracing; to reduce risk of reinfection and onward transmission.
- Liaise with specialist sexual health service for partner notification.

3 QUALITY

Good record keeping. Production of an appropriate clinical record using appropriate read codes and adequate recording should be made in the patient's electronic record.

STI services should be managed in accordance with the FRSH, BASHH, TAM and/or NICE guidance.

Effective prevention and control of Health Care Associated Infection (HCAI) should be embedded into everyday practice and applied consistently by everyone. The General Practitioner must ensure that patients, staff and other persons are protected against the risk of acquiring a HCAI, through the provision of appropriate care, in suitable facilities, consistent with good practice.

Staff undertaking care of under 18s should follow local and national guidance on safeguarding children. All under 16s should be assessed for competency according to Fraser Guidelines.

The Mental Capacity Act should be followed for adults (and young people aged 16-17 years) with learning difficulties or where there is impairment of decision making.
